## 2. Welcome to New Member

# 4. Practice Update

Growth and Statistics:

- Practice grown by 847 patients in last 12 months
- Current patient list: 13,335 (exceeding predicted 12,775)
- 37% of patients on repeat medications
- Depression remains most prevalent long-term condition (14% of population)
- November appointments: 5,176 (highest this year)
- DNA rate: 1 in 19 appointments (267 missed appointments, 50 hours lost)
- Appointment modes: 77% face-to-face, 22% telephone

#### Staffing Updates:

- Nurse Lauren departed
- New nurse Julie joined (nurse practitioner/chronic disease management)
- New nurse practitioner joining in February
- New Practice Nurse joining in February

- Dr Calver commencing maternity leave
- Dr Alam joining as maternity cover
- Dr Aung departing for Australia in January; replacement secured

Care Home Services:

- Now providing services to both Fleming House and Alston House care homes
- Dedicated GP ward rounds established for both facilities

New Initiatives:

- Transitioning from eConsult to Rapid Health system in January
- Soft launch planned with GP monitoring
- System will maintain telephone access option

5. Patient Behaviour Concerns

- Significant increase in abuse towards staff noted
- Recent security incident requiring practice lockdown
- Zero tolerance approach to abuse being reinforced

- Newsletter being prepared to address these issues, PPG members shared their feedback and supported the newsletter

- 6. GP Collective Action
- Practice participating in BMA-suggested actions
- Focus on safe working practices
- Implementation of 32-patient daily limit per GP
- Aim to highlight funding and workload issues
